## New Labeling Standards for Europe, USA

Both the European Union and the USA have officially adopted new labeling standards for down and feather products.

### EUROPEAN STANDARDS

In December 1999, the European Committee for Standardization (CEN) adopted new standards for labeling down and feather products. CEN spent 8 years developing test methods and labeling standards.

The CEN member countries are:

In Germany the new standards are effective May 1, 2000.

The new label divides products by "CLASS". Classes 1-3 are waterfowl products. Class 1 is

the highest quality level. (See attached document for details.)

### NEW USA 2000 STANDARD

New labeling standards have been announced in the USA. The USA has the strictest yet simplest standard in the world.

"DOWN" products must now have at least 75% down cluster. Blends must label the actual down cluster % on the law tag. The FTC expects products to **now** comply with the idea of the new standard regardless which law tag label system is used.

New labels can be used starting

**April 1, 2000.** Retail stores have until **June 1, 2001** to sell products with old law tag labels. (**January 1, 2001** in California.)

### "CLUSTER" - World-wide term for down components.

IDFL proposes that "**CLUSTER**" or "**DOWN CLUSTER**" be used world-wide to describe the following group of components:

1. Downs (pods or pieces)
2. Nestling Downs
3. Plumules

"DOWN" has many meanings. Some countries have four separate definitions for "DOWN"

### DOWN & FEATHER PRICE INCREASES IN CHINA

Down, especially goose down, is in short supply in China. Prices have increased by as much as 30% recently.

Short supplies compounded by strong demand in Japan and the USA may cause problems for buyers later this year.

Manufacturers should monitor

the following signs to **avoid** quality problems:

1. Excessive wash loss in raw materials.
2. Higher than normal duck in goose material.
3. Higher landfowl feathers in waterfowl products.
4. Higher than normal fiber content in products.

Rachel Kasteler is an Analyst at IDFL. She is a 5-year veteran of down and feather testing, having joined the company in 1994

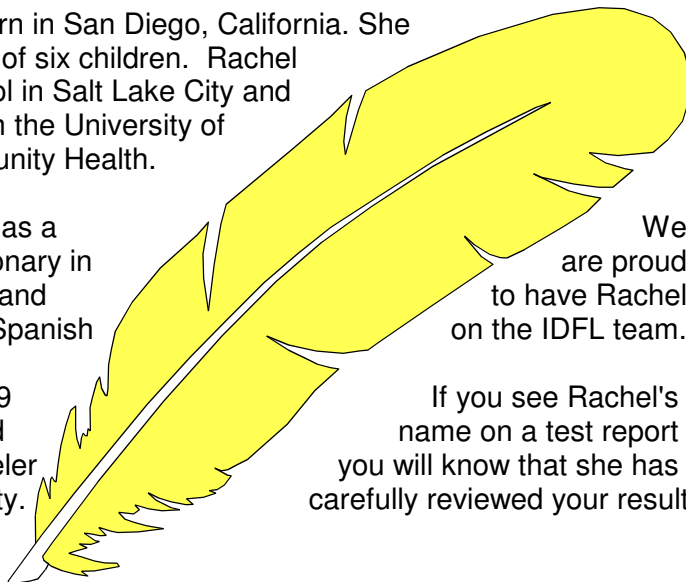
Rachel was born in San Diego, California. She was the oldest of six children. Rachel attended school in Salt Lake City and graduated from the University of Utah in Community Health.

# **IDFB TEST METHODS ARE NOW USED WORLD-WIDE**

The new European Standards and new USA standards both specify IDFB testing methods to determine compliance with government regulation.

The current IDFB test method for composition (or content analysis) was first developed by Wilford Lieber Sr. over 30 years ago. Wilford has worked tirelessly to achieve world-wide acceptance of this test method.

IDFL continues to work with IDFB and other leading organizations to improve down testing and classification procedures.

IDFL is currently working with Hohenstein, Germany and the Japan Down Products Corporative Association on improving the reliability of Oxygen and Turbidity Testing.
