AD&FS Reaffirms USA Labeling Standards

On October 11, 2002, the American Down and Feather Section of HFPA reaffirmed its position that all down and feather products sold in any state of the USA should use the new labeling standard.

(To avoid confusion with old standards, IDFL will always refer to the new labeling laws as the “**USA-2000 Standard**”)

The new labeling standard was developed in 1999 by ABFLO (Association of Bedding and Furniture Law Officials) and adopted by the old American Down Association. California first implemented the new standard in 2000.

The FTC has stated that the **USA 2000 Standard** meets their criteria for down and feather labeling.

Also, the FTC states that the new criteria for labeling must be followed for jackets & other garments as well as bedding.

GOOD NEWS FOR LORCH CUSTOMERS

THREADCOUNT CONTROVERSY

High threadcounts of 2-ply yarns have become a controversy during 2002 culminating in discussion on ABC's Good Morning America November 22, 2002.

Industry and government have commented on the subject:

1. *The ASTM standard method for threadcount (D3775) counts 2-ply yarn as one unit.*
2. *The American Textile Manufacturer's Institute (ATMI) states that counting 2-ply yarn as 2 threads “..would be false and misleading...”*
3. *The FTC began an investigation into high threadcounts, but closed the case when the company involved changed the label from “760 threadcount” to “finely woven 380 2-ply fabric”.*

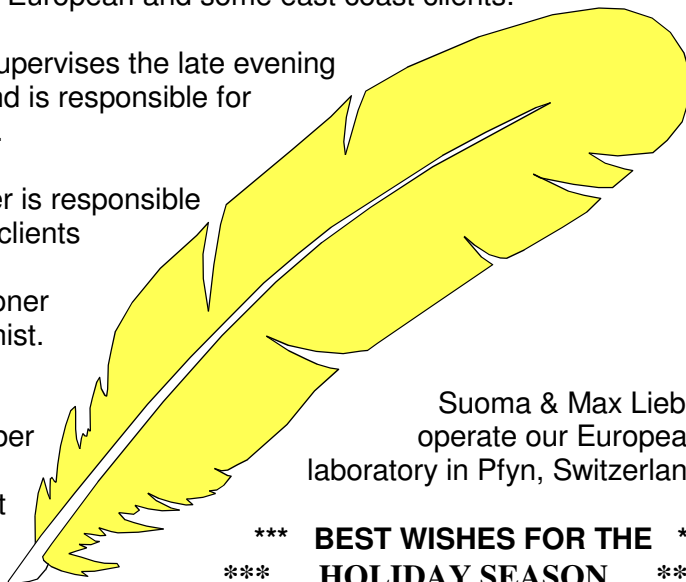
