

## **OFFICIAL NEWS FROM EUROPEAN UNION**

- 1. This information is contained in the Official Journal of the European Union. Article 4 of the Commission Decision states the following:**

### **Article 4**

**1. Member States shall suspend the importation from Cambodia, Indonesia, Japan, Laos, Pakistan, the People's Republic of China including the territory of Hong Kong, South Korea, Thailand and Vietnam of:**

- unprocessed feathers and parts of feathers, and**
- 'live birds other than poultry' as defined in Decision 2000/666/EC, including birds accompanying their owners (pet birds).**

**2. For the importation of processed feathers or parts of feathers (excluding processed decorative feathers, processed feathers carried by travellers for their private use or consignments of processed feathers sent to private individuals for non industrial purposes) a commercial document stating that the processed feathers or parts thereof have been treated with a steam current or by some other method ensuring that no pathogens are transmitted shall accompany the consignment." -- Official Journal of the European Union**
